
Feedback Analysis Report (2022-2023)





According to you, was the curriculum relevant to the needs of the society? 36 responses




Do you think that the current curriculum was/is relevant to the needs of Industry? 36 responses




Do you feel that the curriculum updated your knowledge?


Do you think that the current curriculum was relevant to the needs of Industry?




Do you think that the curriculum enhanced your skills?
