#### MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (the "MOU") is entered on 26/03/2022 between Nauashad Ali Sarovar Samvardhini (hereinafter called NASS) and HVPS Ramniranjan Jhunjhunwala College Ghatkopar, Mumbai

### **BACKGROUND OF NAUASHAD ALI SAROVAR SAMVARDHINI (NASS):**

Nauashad Ali Sarovar Samvardhini (NASS) is a body constituted for the conservation of urban lakes in Mumbai base on the Sarovar Samvardhini concept. NASS initiated its field activities at Powai Lake since February 2008. It is registered as an NGO for promotion of the aims and objectives of Sarovar Samvardhini. A field station dedicated to the fond memory of Late Dr. M.S. Kodarkar, an International Expert on Lake Management and former Secretary, Indian Association of Aquatic Biologist (IAAB) was established on 8th September 2012. Dr. M.S. Kodarkar Field Station was inaugurated by Dr. Walter Rast, Vice-President, ILEC, USA. Dr. M.S. Kodarkar Field Station Laboratory was inaugurated on 5th June 2016 by Former Chief Secretary, Government of Maharashtra, Shri. Johny Joseph. It is located on the Powai lake in the premises of MSAA. The field station provides facilities for field work to the students, researchers, NGO and citizens interested in the environmental issues of Powai lake apart from sharing literature on environmental aspects of lakes and their conservation. Museum on flora and fauna of Powai lake is proposed to be established in future.

#### **BACKGROUND OF COLLEGE**

The RAMNIRANJAN JHUNJHUNWALA COLLEGE basically aims at not only catering to the academic excellence of the students but also providing them with facilities to develop their other inherent talents. The program aims at training students who would contribute effectively to take measures to save the planet. The program would prepare students to utilize the natural resources in a responsible manner and also would look for alternatives. They would mitigate issues of selected ecosystem, conservation of all life forms. Students would have an opportunity of undergoing projects in solving environmental issues and disaster management.
