Report of the Structured Feedback on Curriculum

Academic Year 2021-22

Feedback on the Curriculum of FYBA Psychology Programme (AY 2021-22) was obtained from three stake holders: 1) Students of SYBA Psychology (2022-23; the same students who studied the respective curriculum in FYBA 2021-22), 2) Peer-Teachers from other colleges, and 3) Industry Persons. It was obtained in online mode through Google forms. It was intended to obtain from these stakeholders - the feedback about the relevance of syllabus as per 'Needs of Industry', 'Needs of Society', 'Orientation of Syllabus towards Skill-Enhancement', whether syllabus is updated in respect of Domain-Knowledge, and how concise is the syllabus. Similarly, their suggestions were sought about the syllabus as well as skill-enhancement / add-on courses. The concerning points on the lines of most of the recommendations gathered through these feedbacks (presented below) were discussed in the previous Board of Studies meeting held on September 21, 2022. The remaining points in the analysis presented below will be put forth in the second meeting of the Board of Studies of Psychology.
