

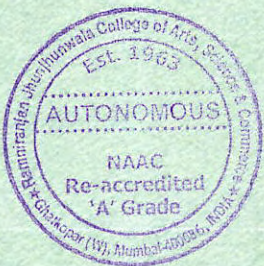

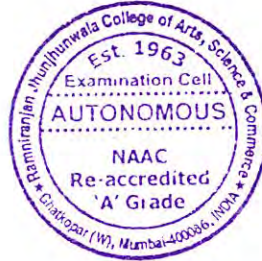
REPORT OF THE ACTIVITY CONDUCTED UNDER MOU WITH S P DESAI COMPANY C A FIRM
