AND

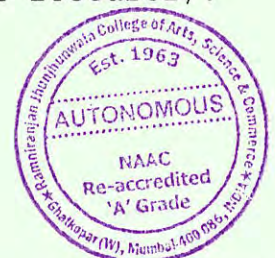

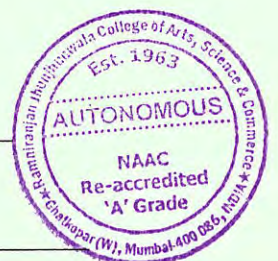
