
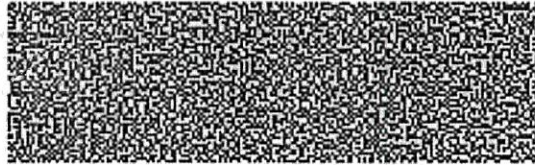
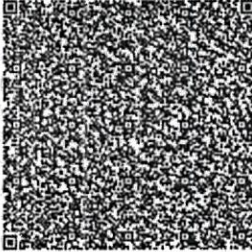

Agreement

This Agreement (herein after referred to as "Agreement") is entered into on this 20th August, 2018 between;

Sambhav Foundation ("Sambhav"), a Charitable Trust registered under Indian Income Tax Act having its registered office at #12, 1st Main, 3rd stage, Vinayaka Layout, Vijayanagar,

Ramniranjan Junjunwala College (GST 27AAATH0417QIZI), an Institute having its office at A-21, HVPS International School, Link Road, Andheri, Near Income Tax office, Opp Mira; hereinafter called the '**RJC**' which expression unless repugnant to the context shall include its successors, assigns etc.

WHEREAS;

Sambhav and RJC wishes to enter into Partnership Agreement wherein infrastructure (venue) of the training will be provided by RJC to Sambhav for conducting the training to the students of RJC in Beauty Health and Care (BHC) trade under Loreal Project.

Now therefore, this Agreement engages the Parties to work together for a period of 3 years i.e. from 1st April, 2018 till 31st March, 2021.

Now this Agreement witnesseth as follows;

1. Both the parties agree to work together on Loreal Project.

2. The duties and functions of RJC shall be as follows;

To take care of basic needs (Housekeeping, Electricity and Water).

3. The obligations of Sambhav shall be as follows;

- To provide Student kit, content books for trainees.
- To do Centre branding.
- To do Mobilization.
- To provide Training and placement to the candidates.

4. Neither Party shall be liable to the other Party for any incidental, special or consequential damages arising out of performance under this Agreement.

5. This Agreement shall come into force from 1st April, 2018 for activities planned and carried out as covered under it for a period of 3 years i.e. till 31st March, 2021 and can be renewed on mutually agreed terms, unless terminated earlier as per the terms of this Agreement. This



Agreement shall come to an end upon the expiry of its Term and/or the renewal period thereof.


6. If either Party is found guilty of any serious misconduct or any serious breach or non-observance of any of the conditions of this Agreement or fails to carry out the reasonable directions of the other Party, the subsisting Party shall be entitled to terminate this Agreement without any notice.
7. This Agreement can be terminated by Sambhav at any time upon giving 30 day's prior written notice to RJC. Upon expiry of the term of this Agreement it may be renewed as discussed mutually between the Parties.
8. This Agreement shall be governed by and in accordance with the laws of India and the Courts of Bangalore shall have exclusive and sole jurisdiction over any disputes, differences or questions arising out of or in connection with or relation to the terms of this Agreement.
11. The Parties shall not, without the prior written consent of the other Party, assign, change or otherwise transfer, delegate or share any provision of this Agreement to any third party whatsoever.
12. No amendment or change hereof or addition hereto shall be effective or binding upon any of the Parties hereto unless the same is reduced in writing with specific reference to this Agreement and executed by the Parties hereto.
13. The relationship hereby established between the Parties is solely that of independent contractors. This Agreement shall not be interpreted as the creation of an agency, partnership, joint venture or employer/employee relationship.
14. This Agreement may be executed two counterparts. Each such counterpart shall be an original and both together shall constitute but one and the same document.
15. This Agreement supersedes all prior or contemporaneous agreements between the Parties concerning the subject matter herein.


